YOU ARE HEREBY ADVISED OF THE ADMINISTRATIVE REGULATIONS AND PROCEDURES

Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms if it is between parties in a horizontal relationship and if it involves collusive Bidding (or Bid rigging). Collusive Bidding is a per se prohibition that cannot be justified under any grounds. It undermines the fair determination of a supplier, corruptly eliminating free and open competition. Therefore, it is not allowed.

1.5	Question	:	Can the service providers select which provinces they want to tender for amongst the 6 provinces as mentioned on the tender document?
	Answer	:	No, bidders are expected to demonstrate that they have a footprint in all provinces and should be able to deliver in all six provinces
1.6	Question	:	Is the briefing session for this this particular tender compulsory?
	Answer	:	Yes
