B. Terms of Reference for the Implementation, Maintenance and Support of Microsoft Great Plains

1. Background

The National Youth Development Agency (NYDA) is a South African based agency established primarily to tackle challenges that the nation's youth are faced with. The NYDA was established by an Act of parliament, act no 54 of 2008. The institution was established to be a single, unitary structure, established to address youth development issues at National, Provincial and Local government level.

The existence of the NYDA should be located within the broad context of South Africa's development dynamics. Similar to many developing countries, South Africa has a large population of youth, those between the ages 14-35; represent 41,9% of the total population. Given the youthful nature of the South African population much of the socio-economic challenges faced by the nation, i.e., poverty, inequality and joblessness, poor health etc., are borne by the youth. The gravity of challenges South Africa is faced with, require multi - pronged efforts, that simultaneously promote the development of sustainable livelihoods, reduce poverty, inequality and prioritize the development of policies which create an enabling environment for youth development.

2. Introduction

The NYDA seeks to appoint a service provider for the implementation, maintenance, and support of Microsoft Great Plains 2018. The appointed service provider will be responsible for upgrading from the current Microsoft Great Plains 2010 and ensuring a seamless transition for the following modules:

Financial Modules

- General Ledger
- Payables
- Receivables
- Bank Management
- Fixed Asset Management

Existing Environment

The current Microsoft Great Plains 2010 system is hosted on-premises and supports over 20 active users. This legacy system operates on Microsoft Dynamics GP 2010, utilizing Microsoft SQL 2008 databases, with both instances hosted on an on-premises Microsoft 2008 R2 server. The system is primarily used for finance operations and includes the following modules:

- Payables
- Receivables
- Reports (e.g., General Ledger, Trial Balance)
- Bank Management
- Fixed Asset Management

3. Scope of Work

The successful service provider shall be responsible for the implementation, maintenance, and support of Microsoft Great Plains 2018 which should be licensed for **30 active users** and hosted on our Azure environment. This might include data migration for FY24/25 from the current Microsoft Great Plains 2010 to Microsoft Great Plains 2018 additionally, the service provider will provide consulting and implementation of services to ensure the optimal functioning of the Microsoft Great Plains 2018 application environment.

Level 1 Support

Service provider support includes:

- Ticket system and telephone call support logging capabilities.
- Utilizing VPN or Phone support resolutions were feasible remote support resolutions.
- Assistance with system technical errors or issues relating to the system.

Level 2 Support

Service provider support includes:

- Provide onsite/remote support for bug and error resolution related to Microsoft Great Plains 2018.
- Provide technical support on projects related to Microsoft Great Plains 2018, including enhancements, upgrades and integrations.
- Configuration and implementation for new functionalities, upgrades and integrations with other applications.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed necessary.
